

HomeStart's - "5 lucky renters Win 5k" promotion

Terms & Conditions of Competition

The "promoters" decision is final and no correspondence will be entered in to.

1. The name of this competition is the “5 lucky renters Win \$5k” promotion (“**Competition**”). The winners will be selected at the HomeStart head office, level 1, Bennett Street, East Perth, WA 6004.

2. The promoter of the Competition is HomeStart trading as J-Corp Pty Ltd (“**Promoter**”)

3. The Competition commences at 12.01am 1 August 2017 (“**Commencing Date**”) and closes at 11.59pm on 31 August 2017 (“**Closing Date**”).

4. For the purposes of the Competition, an “**Entry**” is effected by **ONLY** the following:

- By completing and entry coupon survey and placing in entry barrel or posting to Homestart within the competition period.
- By only submitting 1 entry per person.
