

## **HomeStart's - "5k for 5 Lucky Renters" promotion**

**Promoter - J-CORP Pty Ltd trading as HomeStart**

### **Terms & Conditions of Competition**

HomeStart's "5k for 5 Lucky Renters" promotion will enter all registrations received on its website promotions page between 1 October 2018 ("Start Date") to midnight 31 October 2018 ("End Date") (collectively, "the Promotion Period") into our renters database and 5 winners will be selected at HomeStart's discretion by 1 November 2018 at the HomeStart head office, level 1, 6 Bennett Street, East Perth, WA 6004.

The five (5) selected winners will each win a prize of \$5,000 (five thousand dollars) AUD, as long as they meet all criteria of these terms and conditions.

This is a competition of skill and there is no cost to enter.

The "promoters" decision is final and no correspondence will be entered in to.

1. The name of this competition is the **“\$5k for 5 Lucky Renters”** promotion (**“Competition”**).
2. The winner will be selected based on the best answer provided as decided by the management team at the HomeStart head office, level 1, 6 Bennett Street, East Perth, WA 6004, in its sole discretion.
3. The promoter of the Competition is J-Corp Pty Ltd trading as HomeStart (**“Promoter”**)
4. The Competition commences at 12.01am 1 October 2018 (**“Commencing Date”**) and closes at 11.59pm on 31 October 2018 (**“Closing Date”**).
5. For the purposes of the Competition, an **“Entry”** is effected by **ONLY** the following:
  - (a) by completing the **“\$5k for 5 Lucky Renters”** registration form on the HomeStart website at [homestart.net.au](http://homestart.net.au);
  - (b) OR submitting an entry coupon at a shopping centre AND
  - (c) by only submitting 1 entry per person.
6. For the purposes of the Competition each **Entrant**, must:
  - (a) be over the age of eighteen years;
  - (b) be able to prove they are currently renting, living with parents or in another situation that does not include owning a home of their own;
  - (c) be an Australian permanent resident or citizen OR a New Zealand citizen;

If the selected winner does not respond within three (3) days of contact a new winner will be selected.

The selected winning entries will be scrutinised by the Promoter after the selection of the winners, and the Promoter reserves the right to exclude from the Competition any entry the Promoter considers does not meet the requirements of these Terms and Conditions. The decision of the Promoter is final and binding and no correspondence will be entered into.

11. Should any of the selected winners not meet the Competition criteria outlined in these terms and conditions then another entry will be selected until a winner that meets all criteria outlined in these terms and conditions is selected.

12. The prize winners must provide suitable identification to the Promoters' satisfaction to be entitled to claim any prize.

13. The Promoter reserves the right to verify the validity of entries and to disqualify any entrant whom they feel may have manipulated the entry process or who submits an entry that is not in accordance with the Conditions of Entry.

#### 14. Entrants Information

(a) By entering the promotion you give HomeStart consent to use your personal information for further purposes and promotions unless you say otherwise.
